### **Re: Cuyahoga County Bike/Scooter Share Program Update**

Dear Colleagues,

As you are aware, the City has paused its participation in the Cuyahoga County Bike/Scooter Share Program whereby residents may temporarily rent scooters from a number of pick up and drop off locations throughout the city. The effort by the City to thoughtfully pilot the program and then evaluate it has been commendable. During the pilot period of the program, over 11,000 scooter rides took place. The program has promoted the reduction of carbon emissions and the improvement of parking congestion in Lakewood. I am hopeful that Council and the Administration can work together to troubleshoot and find solutions to make scooter use successful in our community. To that point, I would like for City Council and the public to have the chance to engage in the details on these matters.

I welcome the Mayor and the Administration to join the Housing, Planning & Development Committee in a discussion of the scooter program and evaluation along with the ongoing active transportation planning efforts. I intend for this meeting to be scheduled on June 26<sup>th</sup>, or shortly thereafter.
